It has been a busy year for the District. Staff has continued to operate popular programs on a limited budget with great success. A household problem waste day was held in June in Ligonier. There were over 160 vehicles that participated and 13 tons of material was collected.

Recycling and composting programs are growing in popularity as everyone strives to be more "green". The electronics recycling portion of the problem waste program has soared in numbers with a 46% increase over last year's collected amount.

Hands-on educational displays were presented at the Earth Day event in DeKalb County and at Kid City in Noble County. Both events were a success with many visitors to the District's booth.

With environmental topics more pertinent than ever, the District Executive Director was asked to participate in several articles that were featured in a national solid waste management magazine.

As we look to 2011, we know it will be another year full of challenges and projects. District Board of Directors and Staff are ready to meet these challenges head on and serve the citizens of DeKalb, LaGrange, Noble and Steuben Counties.

Household Problem Waste Program

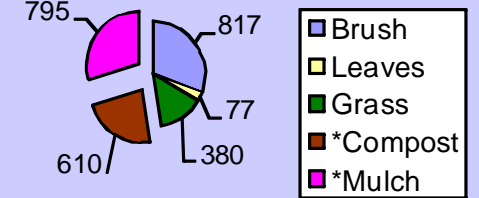

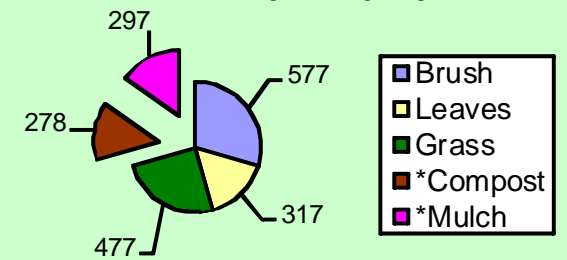

Waste Minimization Program

Throughout the past year, 186 businesses contacted the District with questions on how to maximize their efforts on recycling and/or reducing their solid waste disposal costs. They were all looking for ways to become “green” and stretch their dollars during a weak economy. Each contact discovered they could reduce their waste stream and effectively save money by recycling fluorescent bulbs, used electronics and a variety of other materials rather than sending the items to a landfill for final disposal.



For nearly two decades the District has provided technical assistance to a mixture of large and small companies where recycling opportunities were identified from waste generated in an office setting or on the production floor. Nucor Building Systems in Waterloo is a company that has utilized the Waste Minimization Program. They take environmental compliance very seriously. Most recently, a waste audit was discussed during a tour of their facility. District staff analyzes the types of waste produced and encourages alternative methods of handling to further the companies reduction efforts.

Whether starting a program from scratch or adding new recycling items to existing programs, planning is essential to its success. Business recycling is easy and cost effective. Make the effort to contact us. You won't be disappointed!

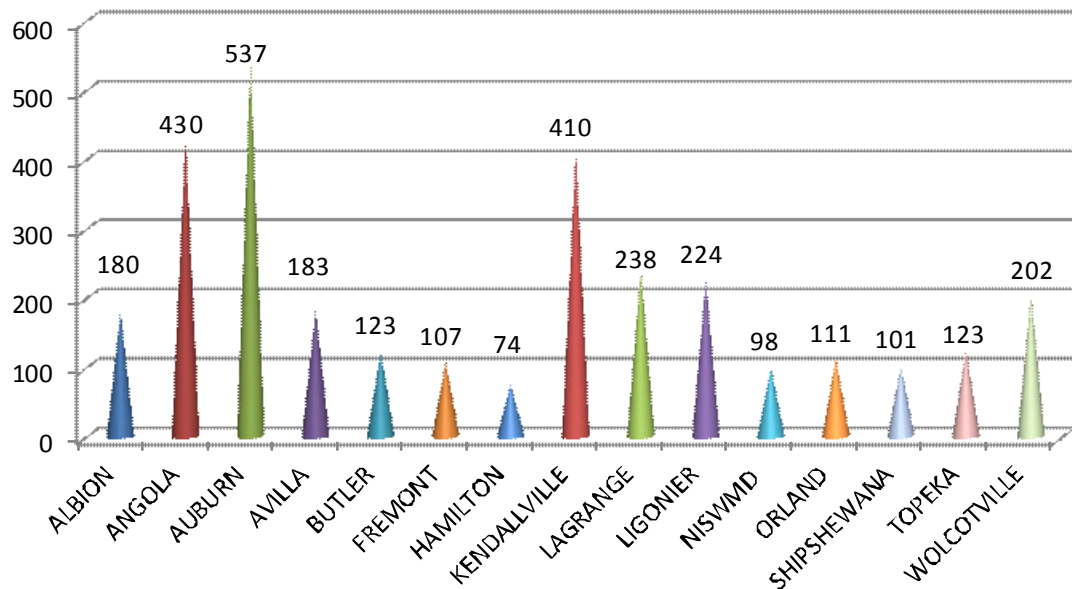

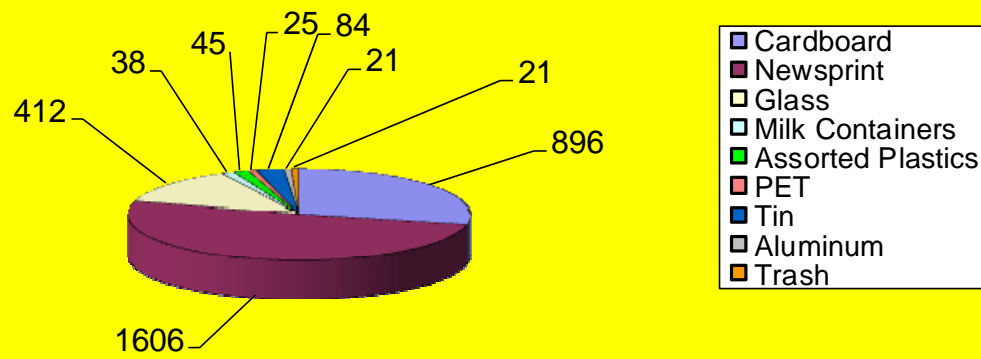

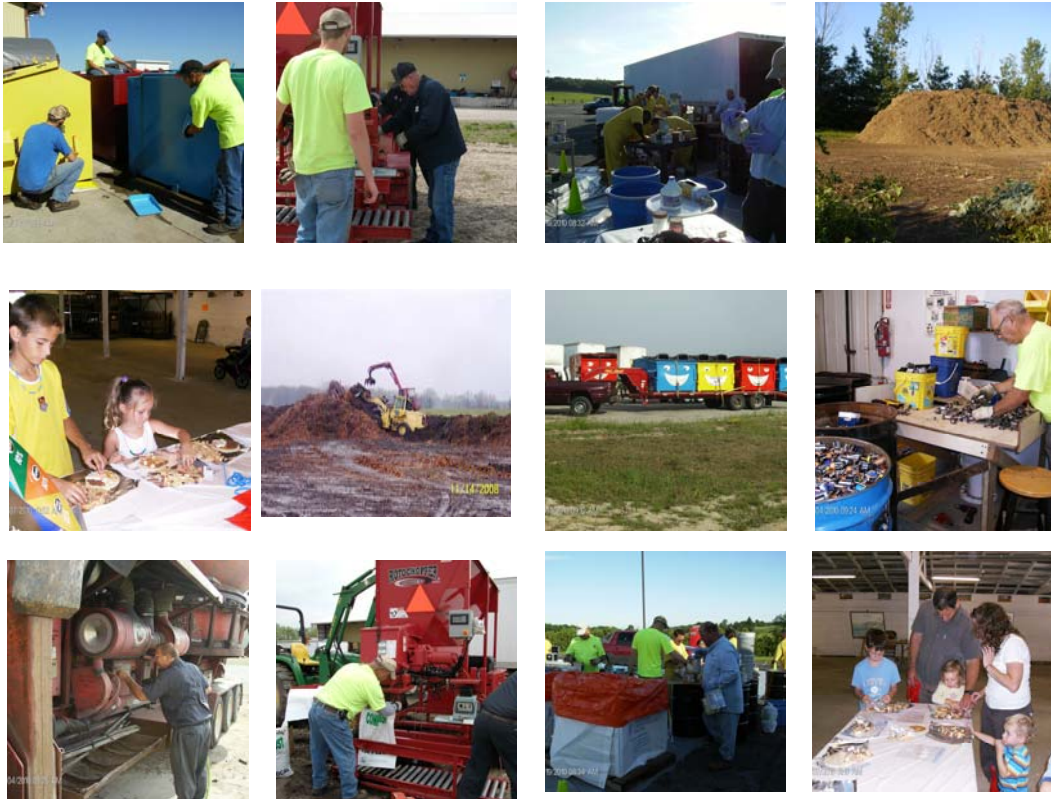
